सैट ने जी प्रवर्तक के अनुरोध पर आदेश सुरक्षित रखा

प्रतिभति अपील पंचाट (सैट) ने मंगलवार को एस्सेल समह चेयरमैन सुभाष चंद्रा और जी एंटरटेनमेंट एंटरप्राइजेज (जी) के प्रबंध निदेशक एवं मुख्य कार्याधिकारी पुनीत गोयनका द्वारा कथित कोष गबन मामले में दायर किए गए अनुरोध पर अपना आदेश सरक्षित रखा है।

भारतीय प्रतिभित एवं विनिमय बोर्ड (सेबी) ने जी प्रवर्तकों को 12 जन को जारी अंतरिम आदेश में कोई प्रमख प्रबंधन संबंधित जिम्मेदारी या निदेशक की जिम्मेदारी निभाने से प्रतिबंधित कर दिया था।

मंगलवार की सुनवाई के दौरान, सेबी के वकीलों ने कहा कि पिछले चार महीनों में बाजार द्वारा जुटाए गई जानकारियों से कोष के कथित गबन का संकेत मिलता है।

वकील ने कहा कि जी ने कोष गबन से संबंधित आरोपों के संबंध में कोई प्रतिक्रिया या स्पष्टीकरण पेश नहीं किया।

आईआईएफएल सिक्योरिटीज को सैट से मिली राहत

प्रतिभृति अपील पंचाट (सैट) ने मंगलवार को आईआईएफएल सिक्योरिटीज को अंतरिम राहत देते हुए बाजार नियामक द्वारा नए ग्राहकों को शामिल करने पर प्रतिबंध संबंधी आदेश पर रोक लगा दी है। सूत्रों ने बताया कि पंचाट ने अपील लंबित रहेने तक आईआईएफएल सिक्योरिटीज को सामान्य तरीके से कामकाज जारी रखने की अनुमित दी है। पंचाट के इस फैसले के बाद आईआईएफएल का शेयर 4.4 फीसदी चढ़कर 63 रुपये पर बंद हुआ। 19 जून को भारतीय प्रतिभृति एवं विनिमय बोर्ड (सेबी) क्लाइंट फंड के कथित दुरुपयोग के लिए आईआईएफएल सिक्योरिटीज को नए ग्राहकों को शामिल करने पर दो साल के लिए प्रतिबंध लगा दिया था।

टाटा टेक्नोलॉजीज, एसबीएफसी फाइनैंस और गांधार ऑयल के आईपीओ को मंजूरी

टाटा मोटर्स की सहायक इकाई टाटा टेक्नोलॉजीज. गांधार ऑयल रिफाइनरी (इंडिया) लिमिटेड और गैर-बैंकिंग वित्तीय एसबीएफसी फाइनैंस को प्रारंभिक सार्वजनिक पेशकश (आईपीओ) के जरिए पुंजी जुटाने के लिए पुंजी बाजार नियामक सेबी की मंजुरी मिल गई है।

तीनों कंपनियों ने दिसंबर 2022 और मार्च 2023 के बीच सेबी के समक्ष आवेदन किए थे। उन्हें 21-23 जून के दौरान नियामक की मंजुरी मिली। मसौदा दस्तावेज के



आईपीओ पूरी तरह से बिक्री पेशकश के रूप है, जहां कंपनी 9.57 करोड़ इक्विटी शेयर बेचेगी, जो उसकी चुकता शेयर पुंजी का अनुसार टाटा टेक्नोलॉजीज का लगभग 23.60 प्रतिशत है। गांधार

ऑयल रिफाइनरी के आईपीओ में 357 करोड़ रुपये के इक्विटी शेयरों की ताजा पेशकश शामिल है, जबिक प्रवर्तक और मौजूदा शेयरधारक 1.2 करोड़ शेयर बेचेंगे। बाजार सूत्रों ने कहा कि बिक्री पेशकश से 500 करोड़ रुपये मिलने की उम्मीद है। गैर-बैंकिंग ऋणदाता एसबीएफसी फाइनैंस आईपीओ के जरिए 1.200 करोड रुपये जुटाने की योजना बना रहा है। इसमें 750 करोड़ रुपये की नयी पेशकश और 450 करोड़ रुपये की बिक्री पेशकश (ओएफएस)

चीन में बढ़ती इस्पात कीमतों और वैश्विक तौर पर लौह अयस्क कीमतों में वृद्धि से भारतीय लौह अयस्क एवं इस्पात क्षेत्र में बदलाव आ सकता है। इसका अनमान है कि चीनी सरकार ऐसी प्रोत्साहन नीति पेश कर सकती हैं जिससे औद्योगिक धातुओं के लिए मजबत मांग को बढावा मिलेगा।

केंद्रीय बजट में इन्फ्रास्टक्चर एवं निर्माण पर जोर दिए जाने और वाहन एवं रियल एस्टेट क्षेत्रों में सधार के संकेतों की वजह से 2023-24 में घरेलू मांग मजबूत रहने का अनुमान है।हालांकि संकेत मिश्रित हैं, क्योंकि सस्ते आयात से प्रतिस्पर्धा बढ़ने की वजह से घरेल हॉट-रॉल्ड कॉइल कीमतों में गिरावट आई है।

चीन को लेकर उत्साह बढ़ने से टाटा स्टील, जिंदल स्टील ऐंड पावर लिमिटेड (जेएसपीएल), जेएसडब्ल्यू स्टील, एनएमडीसी, और सेल में निवेशकों की दिलचस्पी को बढावा मिला है। जेएसपीएल कई विश्लेषकों का पसंदीदा शेयर है।

जेएसपीएल अगले 12 महीनों के दौरान दो चरणों में 65 प्रतिशत तक की क्षमता वृद्धि से जुड़ी परियोजनाओं से जुड़ी हुई है। कुछ विश्लेषकों को अगले तीन साल के दौरान 19 प्रतिशत और 17 प्रतिशत एबिटा और ईपीएस दर्ज किए जाने का अनुमान है।
